National Motor Freight Classification Rules

Rule 300203 Filing and Processing Claims

a. A claim for overcharge, duplicate payment or over- collection shall not be paid unless filed in writing or electronically communicated (when agreed by the carrier and shiper or receivor involved) with the carrier that collected the transportation charges. The collecting carrier shall be the carrier to process all claims. When a claim is filed with another carrierthat participated in the transportation, that carrier shall transmit the claim to the collecting carrier within 15 days after receipt of claim. If the collecting carrier is unable to dispose of the claim for any reason, the claim maybe filed with or transferred to any participating carrier for final disposition.

b. A single claim may include more than one shipment, provided the claim on each shipment involves (1) the same tariff issue or authority or circumstances (2) single-line service by the same carrier or (3) service by the same interline carriers.

Rule 300204 Documentation of Claims

a. Claims for overcharge, duplicate payment or overcollection shall be accompanied by sufficient information to allow the carriers to conduct an investigation and pay or decline the claim within the time limitations set forth in Item 300208. Claims shall include the name of the claimant, its file number, if any, and the amount of the refund sought to be recovered if known.

b. Except when the original freight bill is not a paper document but is a electronically transmitted, claims for overcharge shall be accompanied by the original freight bill. Additional information may include, but is not limited to, the following:

- 1. The rate, classification, commodity description, or weight claimed to have been applicable.
- 2. Complete tariff authority for the rate classification or commodity dscription claimed.
- 3. Freight bill payment information.
- 4. Other documents or data that are believed by claimant to substantiate the basis for its claim.

c. Claims for duplicate payment and over-collectionshall be accompanied by the original freight bill(s) for which charges were paid (except when the original freight bill is not a paper document but is electronically transmitted) and by freight bill payment information.

d. Regardless of provisions of paragraphs a,b, and c of this item, the failure to provide sufficient information and documention to allow a carrier to conduct and investigation and pay or decline the claim within the allowable time limitation shall not constitute grounds for disallowance of the claim. Rather, the carrier shall comply with Item 300205 (c) to obtain the additional information required.

c. A carrier shall accept copies instead of the original documents required to be submitted in this Item were the carrier is furnished with an agreement entered into by claimant that indemnifies the carrier for subsequent duplicate claims that might be filed and supportated by the original documents.
